Appropriate Online Behaviors

Dear BBMS Families,

I want to take a moment and share a concern with you and ask that you take time to talk with your student(s) about online behavior.

We realize from time to time that we must revisit guidelines with students as a reminder for how they should act during Google Meet sessions, how they communicate with others, and explain what to do if things don't seem appropriate. This is part of learning and growing up; and a message we hope students continue to carry with them long after they leave BBMS.

Today, we took time to remind our 8th grade students that they should never take photos or videos of anyone during a Google Meet session.

Here is the statement we shared during 8th grade classes today:

"8th Grade Teachers will have cameras off today.

A student at Bonnie Branch took a picture of an 8th grade teacher during a Google Meet

without permission and shared that picture with others.

It is not okay to share a picture without that person's consent

and it violates policy 8080 (appropriate use of technology).

Teachers keep their cameras on to help you learn; it is a privilege, not a requirement.

Teachers are people. We deserve to feel safe and respected."

Teachers started the first few minutes of class without their camera on. Then, they held a brief conversation with students about appropriate behaviors and possible consequences to remind students that they have a responsibility to contribute to a

safe learning environment. We did not name the teacher nor any of the students involved. We also emphasized that everyone deserves to feel safe: students, teachers... everyone. We also emphasized ways that students can be a part of the solution by talking with trusted adults and letting their friends know when something is "just not right".

We know that virtual learning can be challenging; and maintaining a safe and supportive environment where students feel comfortable comes first. Thank you for talking with your student(s) about this and for helping to reinforce this message. We are proud that incidents like this are not common at BBMS and know our students will do their part to ensure that all classrooms are safe spaces for each and every student, staff or guest.

GOOGLE MEET SAFETY MEASURES

Please take a few moments to review the following information regarding appropriate behavior and engagement during Google Meet Sessions:

- Adhere to HCPSS Policy 8080 Responsible Use Technology and Social Media and other relevant HCPSS policies.
- Students will only be permitted into a Google Meet session with a HCPSS email account. All students can be identified through their HCPSS email account.
- Inappropriate/offensive/threatening comments, misrepresentation of identity, and/or disruptive participants (invited or uninvited) during Google Meet sessions will not be tolerated.
- No one should take photos or videos of another person during a Google Meet session.
- Sharing login information violates the confidentiality rights of other students and places them at risk of having to witness disruptive behaviors from students who are not members of the class or school community.
- Students who are disruptive and/or "trespass" Google Meet sessions will be immediately reported to administration and will receive appropriate consequences in accordance with the HCPSS Code of Conduct. Consequences may result in temporary or permanent loss of technology access, which will also result in a student's inability to participate in Google Meet sessions; arrangement for receiving instruction and assignments will be established by administration communicated and arranged with parents.
